ORDER

- 1.As per paper read (1), the Regulations for PG Programmes (CBCSS) under Private Registration 2020 admission were implemented and certain modifications were effected to the same as per paper read (2) above.
2. As per the paper read (3) above, mode of Internal Evaluation of PG Programmes under Private Registration on the basis of Assignment was modified, limiting it to first and second semester of 2020 admission and to opt objective type test for Internal evaluation from third semester onwards for 2020 admission, and for all semesters of 2021 admission onwards.
3. Syndicate, as per the paper read (4) above, resolved that **"the internal assessment of all semesters of UG and PG programmes under Private Registration scheme of 2020 and 2021 admissions shall be based on Assignment"**
4. Accordingly, School of Distance Education (SDE) issued Notification modifying the mode of internal Evaluation for UG and PG Programmes under Private Registration 2020 and 2021 admissions, as per paper read (5) above.
5. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 accorded sanction to implement revised mode of Internal Evaluation of PG programmes (CBCSSOBE) under Private Registration as detailed in para (3) above and to report the same to the Academic Council.
