ORDER

- 1. The Statutory Finance Committee of the University had been reconstituted as per the University orders referred to (i) above.
- 2. The University Senate in its meeting held on 19th July, 2024 elected Sri. Saju P. J. (Member of the Senate) as the representative of the Senate to the Statutory Finance Committee as referred (ii) above.
- 3. Further, vide reference (iii) above, the University Syndicate nominated Smt. N. Sukanya as the representative of the Syndicate to the Statutory Finance Committee.
- 4. Considering the resolutions, the Hon'ble Vice-Chancellor has accorded sanction to reconstitute the Statutory Finance Committee by incorporating Sri. Saju P. J. as the nominee of the Senate and Smt. N. Sukanya as the representative of the Syndicate to the Statutory Finance Committee, vide the orders cited (iv) above.
- 5. Accordingly, the existing University Order reconstituting the Statutory Finance Committee is revised, by incorporating the nominations of the Senate and the Syndicate, with following members;
 - i. The Vice Chancellor, who shall be the Chairman
 - ii. The Pro-Vice Chancellor
 - iii. **Sri. Saju P. J.**, Member of the Senate elected by the Members of the Senate from among themselves
 - iv. Smt. N. Sukanya, Member elected by the Members of the Syndicate from among themselves
 - v. **Sri. Raghunath P.**, Member of Academic Council elected by the members of the Academic Council from among themselves
 - vi. The Finance Secretary to Government or an officer of the Finance Department, not below the rank of Joint Secretary to Government, nominated by the Government
 - vii. The Secretary to Government, Higher Education Department or an officer of the Higher Education Department, not below the rank of Joint Secretary to Government, nominated by the Government
 - viii. The Finance Officer of the University shall be the Secretary of the Finance Committee
- 5. The members shall hold the office for a period of four years.
- 6. Orders are issued accordingly.
