ORDER

- 1. Vide the paper read (1) above, University Order was issued granting the last chance for Re-Registration (applicable to all semesters) for the candidates of B.Tech. 2012 and earlier admission (Regular), 2011 & earlier admission (for Part Time), after levying a Re-Registration fee of ₹5000/-(Rupees five thousand only) and ₹500/- (Rupees Five hundred only) per paper, with a provision to conduct Mercy Chance examination.
- 2. Meanwhile,the Examination Monitoring Committee held on 19.01.2021 recommended to notify Examinations of all Semesters (S1 & S2 to S8) of the B.Tech. Programmes for the candidates belonging to 2007 to 2014 Admissions. It was also recommended that this marathon examination shall be the last chance for the candidates admitted to the programme from 2007 to 2010 admissions. The candidates admitted for the B.Tech. Programme from 2011 to 2014 will be given further chances to take Supplementary examinations as per regulations, in addition to the above marathon examinations.
- .3. As per paper read (2), the meeting of the Syndicate held on 16.02.2021 vide item no.2021.146 resolved to approve the aforesaid Minutes of the Examination Monitoring Committee held on 19.01.2021. Accordingly, the Examination Branch notified the I & II Jan 2020, IV May 2020, VI May 2020, VII Nov 2020 and VIII April 2020 examinations, except the III Semester (Oct.2020) and V Semester (Nov 2020) exams.
- 4. As per the U.O. read (1) above, the candidate of 2007-10 admissions, wishing to appear for the III Semester (Oct 2020) and V semester (Nov 2020) examinations, will have to reregister, as the III & V Semester Supplementary examinations have already been conducted for them.
- 5. The Examination Branch, as per paper read (3), requested to take steps regarding granting Re-registration to the candidates of 2007 to 2010 admission, only for the III Semesters (Oct 2020) and V Semesters (Nov 2020) examinations, so as to issue a notification in this regard.
- The existing Re registration fee of Rs.5000/- (Rupees Five Thousand only) collected from a
 candidate is applicable to all semesters, in addition to the normal examination
 fee. The candidates of 2007 to 2010 admission need Re-Registration only for the two
 semesters, (i.e., for III and V semesters).
- 7. Hence, as ordered by the Vice Chancellor, the matter was placed before the Syndicate to fix

- the Re-registration fee for the two exclusive Semesters[as stated in the Para 6] and to consider the extension of this benefit to the Part time candidates also.
- 8. As per paper read (4) the meeting of the Syndicate held on 13.07.2021 vide item no. 2021.389, considered the above matter and resolved to fix the Re-registration fee as ₹ 2000/- (Rupees Two Thousand only) for two Semesters (III Oct 2020 & V Nov 2020) examinations, in addition to the normal Exam fee and to make applicable the same for the Part -time B.Tech, candidates also.
- 9. The Vice-Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(1) Chapter III of Kannur University Act 1996 and other enabling provisions read together with, issued the following orders.
- One last Chance is granted for Registration to the B.Tech. candidates of 2007 to 2010 admissions, only for the III semester (Oct 2020) and V Semester (Nov 2020) Examinations, after levying a Re-registration fee of ₹ 2000/- (Rupees Two Thousand only), for two semesters (III Oct 2020& V Nov 2020), in addition to the normal Exam fee.
- The same fee shall be applicable to the Part-Time B.Tech. candidates also.

Orders are issued accordingly.
