ORDER

1. As per paper read (1), the Regulations for UG Programmes (CBCSS-OBE) under Private Registration 2020 admission were implemented and certain modifications were effected to the same as per paper read(2) above.

2. Clause 3.9 states that "Those candidates who have been awarded B.Com degree of this University or B.Com degree of other University/Institution recognised as equivalent thereto, may be permitted to appear for Elective Papers of Cooperation of B.Com programme under this regulations. Such candidates may be registered for examination along with third year batch of the academic year concerned and they shall take the examinations of all elective courses in Cooperation distributed in III and V semester in November session and those of IV and VI semesters in March session in one academic year. Successful candidates under this provisions may be issued certificate of B.Com additional co-operation signed by the Controller of Examinations".

3. The combined meeting of Standing Committee of Syndicate on Course, Research, Library & Publication and School of Distance Education, as per the paper read (3) above recommended to offer Certificate course in Additional Optional Co-Operation to B.Com Degree holders of this university or of other Universities recognized as equivalent. Such candidate shall take examinations of papers in Optional Co-Operation as per the Scheme and Syllabus of B.Com Private Registration excluding the internal evaluation component. Examination for 4 papers shall be conducted at the end of one academic year separately for these candidates.

4. As per the paper read (4) above, the Syndicate resolved to approve the aforesaid recommendation with a modification that Internal Evaluation be followed for additional Co-operation Course with assignment, as in the case of other UG programme under Private Registration.

5. As per the paper read (5) and (6) above, the Director, School of Distance Education submitted the details of modification to be effected in Clause 3.9 and name of Four Elective Courses for including the same in the University Order, implementing the modification and requested to amend the clause 3.9 Regulation of UG Programmes under Private Registration in tune with the aforesaid Syndicate Resolution.

6. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 accorded sanction to modify Clause 3.9 of Regulations for the UG programmes (CBCSS-OBE) under Private Registration as detailed below and to specify the Name of Four Elective Papers in this order and to report the same Academic Council.

Clause 3.9 : "Those candidates who have been awarded BCom degree of this University or BCom Degree of other University/Institution recognised as equivalent thereto, may be permitted to appear for Elective Papers of Cooperation of BCom programme under this regulations. Such candidates shall take examinations of papers in optional (Elective) Co-operation as per the scheme and syllabus of B.Com Private Registration. Examinations for four papers shall be conducted at the end of one academic year separately for these candidates. The Internal Evaluation be followed for additional Co-Operation with assignment, as in the case of other UG Programme under Private Registration. Successful candidates under this provision will be issued certificate of B.Com additional Co-operation signed by the Controller of Examinations"


