ORDER

1.As a few students of B.Sc. Nursing Course, has not completed the course within 8 years time frame as per the regulation of the course, the examination branch vide paper read(1) above, requested to clarify whether the IIIrd and IVth year examination conducted in August 2016 for such candidates can be released.

2. The matter was placed in the BOS of Nursing meeting held on 29th July 2017 vide paper(2) above. As there were no individual representation/request from any students or from the principals of the concerned colleges, the board informed that they were not able to take a common decision on the matter and requested the University to provide details with respect to the number of Supplementary exams conducted by the University after 2013, year of admission of each student, number of attempts made by the candidates etc.

3. On receiving the information sought by the board vide reference (3) above, the matter was again placed in the meeting of the BOS in Nursing(Cd) held on 21/11/2017 vide paper read (4) above.

4. The BOS considered the matter and recommended to take steps to publish the results of III & IV year B.Sc. Nursing exams conducted in August 2016 on the following grounds.

a. The students have got less number of chances to pass the exam within a time frame of 8 years, as yearly only one examination was conducted for the course since October 2013, though as per the regulation two examinations must be conducted in a year. Moreover some students are yet to complete 8 years time frame at the time of appearing for the exams of August 2016.

b. In similar case, the Indian Nursing council has granted Mercy chance on humanitarian ground for students of B.Sc. Nursing course of Kerala University to appear for examination after completion of 8 year time frame.

5.The Board also suggested that the Registrar of University may request Indian Nursing Council to consider the waving off the 8 year time frame for completion of course for these students following the inception of Kerala University of Health Science and also conduct of supplementary exams for the failed candidates can be taken after getting favourable reply from Indian Nursing Council.

6. The Vice-Chancellor, after considering the matter in detail, and in exercise of the powers of the Academic Council, conferred under Section 11 (1) of Kannur University Act, 1996 and all other enabling provisions read together with, has accorded sanction to publish the results of IIIrd & IVth year B.Sc. Nursing exam conducted in Aug 2016 ,as recommended by the Board of Studies in Nursing (cd) vide para (4) , subject to report to the Academic Council.

7.Orders are ,therefore, issued accordingly.
