1. As per paper read (1) above, Modified the Scheme, Syllabus of the new generation programme Bachelor of Multimedia and Communication (CBCSS-OBE) was implemented in the Affiliated College with effect from 2020 admission.
2. Meanwhile, the Examination Branch vide paper read as (2) above, requested to solve the discrepancy in the Nomenclature of the programme, mentioned in the Affiliation Order and the in the Syllabus of the Programme. In the Affiliation Order, the nomenclature of the programme 'Multimedia' was mentioned as as single word, whereas, in the approved Syllabus and U.O. concerned, 'Multimedia' was mentioned as 'Multi' & 'Media' as two words.
3. Subsequently, the Remarks of Chairperson, Board of Studies (BoS) in Journalism & Mass Communication(cd) was sought in this matter and in reply, the Chairperson, vide paper read as (3) intimated that, Multimedia is single word. Hence suggested to correct the nomenclature of the Programme.
4. The Vice Chancellor approved the aforesaid Remarks of the Chairperson,BoS and ordered that abbreviation has to be modified accordingly and also ordered to place the matter before the Academic Council.
5. The XXIX th Meeting of the **Academic Council held on 21-12-2024 vide paper read (4) above, approved the Modification of abbreviation of the programme, Bachelor of Multimedia and Communication as "B.M.C." instead of B.M.M.C.**
6. The Minutes of the Academic Council was approved by the Vice Chancellor.
6. Therefore, the name of the Programme in the Scheme and Syllabus of the programme is corrected to be read as "**Bachelor of Multimedia and Communication (B.M.C.)**."
7. The U.O read as paper (1) above, stands modified to this extent.


