1. As per paper read (1) above, provisional affiliation was granted to the BCA Data Science programme at De Paul Arts & Science College, Edathotty, Kakkeyangad , for the academic year 2025–26.
2. The Board of Studies in Computer Science (UG), at its meeting held on 04.10.2025, vide paper read (2) above, recommended that the eligibility criteria and index mark calculation criteria for admission to the the newly sanctioned BCA Data Science Programme are similar to the criteria for admission to the FYUG BCA programme of Kannur University.
3. As per paper read (3) above, the Dean, Faculty of Technology recommended approval of the above recommendation of the Board of Studies in Computer Science (UG) .
4. The Standing Committee of the Academic Council held on 05.12.2025, vide paper read (4) above approved the the above recommendation of the Board of Studies in Computer Science (UG) regarding the eligibility criteria and index mark calculation criteria for admission to the newly sanctioned BCA Data Science Programme.

The Vice-Chancellor, after considering the matter in detail , and in exercise of the powers of the Academic Council conferred under Section 11(1), Chapter III of the Kannur University Act, 1996, and all other enabling provisions read together therewith, approved the Eligibility Criteria and Index Mark Calculation for the FYUG BCA Data Science programme, as recommended by the Board of Studies in Computer Science (UG) and accorded sanction to implement the same w.e.f the Academic year 2026-27, as follows.



**Eligibility Criteria:**

A Pass in Higher Secondary Examination of the State or an Examination accepted by the University as equivalent thereto with Computer Science/Mathematics/Computer Application/ Informatics Practice as one of the subjects.

**Index Mark Calculation:**

Total marks of the qualifying examination+ marks for Mathematics +20% of the marks for Computer Science/Electronics.
