**ORDER**

1. As per paper read (1) above, the Regulations for UG Programmes under Choice Based Credit & Semester System (CBCSS) in Affiliated Colleges were implemented in the University w.e.f. 2019 admission.
2. As per second para of Clause 11.1 in the existing Regulations of UG Programmes under CBCSS implemented in the University w.e.f 2019 admission, "*Position certificate up to 10<sup>th</sup> Position, will be issued on the basis of highest OGPA secured for the programme*
3. Meanwhile, as per paper read (2) above, the Annual meeting of Kannur University Senate, resolved to place the matter of issuing Rank certificate instead of Position Certificate, before the Standing Committee on Examinations.
4. Further, the MSF District Committee vide paper read (3) above submitted a representation to take urgent steps to issue Rank Certificate, pointing out that UGC is insisting 'Rank Certificate' for all services, including the Scholarships and submitted that due to the non receipt of Rank Certificates, the students are deprived of the Scholarships.
5. Subsequently, the matter was placed before the Syndicate and vide the paper read (4) above and the Syndicate resolved to issue Rank Certificate, instead of Position Certificate to the UG candidates, with effect from 2017 admission onwards and to make amendments in the UG Regulations.
6. The Vice Chancellor, after having considered the matter in detail and in exercise of the powers of the Academic Council as per section 11(1) Chapter III of Kannur University Act 1996, accorded sanction to amend the second para of clause 11.1 in the Regulations for UG Programmes, under Choice Based Credit & Semester System implemented in Affiliated Colleges w.e.f 2019 admission, subject to the reporting to the Academic Council.
7. The following amendment is therefore issued with regard to second para of clause 11.1 of the Regulations of the UG Programmes, under Choice Based Credit and Semester System implemented in Affiliated Colleges w.e.f 2019 admission. **'Rank Certificate' (up to 3rd rank) shall be issued instead of Position Certificate, to U.G.(Under Graduate) candidates with effect from 2019 admission onwards, on the basis of highest OGPA secured for the programme.**
8. The U.Os read (1) above stand modified to this extent.

Orders are therefore issued accordingly.
