PROSPECTUS FOR ADMISSION TO THE M.Ed. DEGREE PROGRAMME IN THE SCHOOL OF PEDAGOGICAL SCIECNCES OF KANNUR UNIVERSITY FOR THE ACADEMIC YEAR 2025-26

1. Introduction

The Master of Education (M.Ed.) Programme is a two year professional programme in the field of Teacher Education which aims at preparing teacher educators and other education professionals including curriculum developers, educational policy analysts, planners, administrators, supervisors, school principals and researchers.

2. Duration of the Course

The Duration of M. Ed. programme is two academic years (400 working days (Four Semester of 100 days each)) including field attachment for a minimum of 4 weeks and research dissertation. Students shall be permitted to complete the programme within a maximum period of three years from the date of admission to the programme. The candidate should earn minimum of 80% attendance and 90% for field attachment out of the total working days in each semester.

3. Number of Seats

The total number of intake is: 35

4. Eligibility for Admission

B. Ed. Degree of the Kannur University or a B. Ed. Degree recognized by Kannur University as equivalent there to with not less than 50% marks.

or

4 year Integrated Teacher Education Degree Programme (B.El.Ed/B.Sc.Ed/B.A.Ed) recognized by Kannur University with not less than 50% marks. (In case of integrated degree Programmes-B.Sc.B.Ed/B.A.B.Ed, aggregate marks/grade in Education papers alone will be considered).

Relaxation in marks will be given to SEBC/OEC/SC/ST, PWBD candidates as per the University Admission Rules.

Age: No upper age limit for M.Ed. admission.

5. Reservation

Reservation rules specifically applicable for SC/ST/SEBC/OEC/EWS and Person with Disability candidates for admission for M. Ed. (Regular) Programme as given below

* *PWBD* -5% of the total seats, over and above the sanctioned strength will be set apart exclusively for persons with benchmark disabilities.

**EWS reservation of 10% shall be additionally created over and above the total strength of seats

The candidates belonging to Economically Weaker Section which does not belong to SC/ST or other backward classes as per reservation rule are eligible for EWS reservation. Such candidates must produce either of the certificates from the village officer namely "The applicant belonging to Anthyodaya Anna Yojana (AAY)and Priority House Hold (PHH) category" or "The income and assets certificate for Economically Weaker Sections (EWSs) in General Category".(Format of certificates are given in Annexure VII & VIII). Ration Card or BPL Certificate is NOT a valid document to avail EWS reservation. Candidates who enjoy Communal Reservation such as SEBC, SC/ST are NOT eligible for EWS reservation.

5.1 Claim for Communal reservation under 'Socially and Educationally Backward Classes' (SEBC)

Reservation of seats to the Socially and Educationally Backward Classes will be in accordance with the provisions contained in G.O. (P) 208/66/Edn dated 02.05.1966, as amended from time to time.

Candidate belonging to SEBC category (List of communities under SEBC category are given in Annexure IV) claiming reservation under SEBC Quota should invariably produce 'Non-Creamy Layer certificate' obtained from the Village officer concerned at the time of admission. Candidate belongs to Non creamy Layer only are eligible for claiming reservation to SEBC category. Only the claims of the candidates of those communities that are included in the Annexure IV of the Prospectus will be considered.

5.2 Claim for Reservation under Scheduled Castes/Scheduled Tribes Quota

Candidates claiming reservation under Scheduled Castes/Scheduled Tribes quota should obtain the caste/community certificate from the Tahsildar. Candidates belonging to SC/ST communities allotted against merit seats or against the seats reserved for them are exempted from payment of fee at the time of admission, with an undertaking that they will remit the fee in full once they receive the e-grants from concerned Department. (See the Annexure I & II for SC/ST list). The seats unavailed by the SC candidates will go to ST candidates and vice versa.

Warning: Those who produce false SC/ST Certificate for claiming reservation under SC/ST quota shall be liable for punishment as per rules.

5.3 Claim of OEC candidates against the un-availed seats of SC/ST candidates

Other Eligible Community (OEC) candidates are eligible for the un-availed seats, if any, under SC/ST quota. The communities given in the list Annexure III of the prospectus only are eligible for unavailed seats, If any under SC/ST quota (G.O. (M.s)No.14/2017/BCDD dated

02.08.2017), The eligible candidates should furnish any document to prove their community and non-creamy layer certificate from the Village Officer/Tahsildar.

Candidates who belongs to SC/ST/OEC communities and 30 other communities who are availing educational concession as given to OEC (Annexure V) are exempted from the payment of tuition fee at the time of admission.

6. General Rules for conversion of vacant seats

- 1. If sufficient candidates are not available for filling the seats reserved for SC/ST candidates, the same will be notified in the media three times (on three different dates). However, even after this, if SC/ST seats are still vacant, such seats will be filled by candidates belonging to Other Eligible Communities (OEC) included in the Annexure III of the Prospectus and in their absence, will be filled as per Government norms
- 2. The seats unavailed under SEBC category candidates will be converted to Open Merit (General) quota in the final stage of admission process
- 3. The seats unavailed under PWBD category shall not be converted.
- 4. The seats unavailed by EWS category seats shall not be converted.

7. Fee

a) Registration Fee: For General Candidates* = Rs. 600/-For SC/ST/PWBD candidates = Rs. 300/-

(*A candidate who does not belong to SC/ST/PWBD community will be treated as a 'General' candidate for this purpose).

The above fee has to be paid through Kannur University SBIePay, by login in to registered profile only.

1) Candidates shall not remit the fee in any other form like Demand Draft, Cheque, Chalan etc.

2) The Registration Fee once remitted will not be refunded under any circumstances. No refund for wrong payment.

b) Programme Fee: Selected candidates should remit tuition fee of Rs 13,200/*-per year (Rupees Thirteen thousand and two hundred only) and other fees fixed by University by way of online payment through SBI collect or SBI chalan receipt at the time of admission (Candidates who belongs to SC/ST/OEC candidates and 30 other communities who are availing educational concession as given to OEC (Annexure V) are exempted from the payment of tuition fee). (*subject to revision)

8. Selection

The selection shall be from the rank list prepared on the basis of the following criteria:

a) Selection is based on the Marks/Grade obtained by the applicant in the Qualifying Examination and Entrance Examination conducted by the University (Entrance Examination will be conducted depending on the number of applicants) and for

A weightage of 5 points/marks will be given to candidates who have taken Qualifying Degree from Kannur University.

b) A weightage of five index points will be given to the natives of Kannur University jurisdiction (i.e. Kannur, Kasaragod Revenue Districts and Mananthavady Taluk of Wayanad Revenue District) for admission to M.Ed. programme in all institutions maintained by or affiliated to the University on production of Nativity Certificate of 5 years issued by the Competent Revenue Authority.

c) Weightage of 5 points/marks will be given to Teachers in Government /Aided School service. The approved service of applicants will be considered in ranking. (0.1 index point will be given for each completed month of experience).

9. Application Procedure

Any candidate who desires to obtain admission under Kannur University for the M.Ed. programme should compulsorily register through online registration before the closure of registration. After the completion of the online registration, the candidate should take the print out of the same for future use (Do not send to the university). The hard copy of the application with supporting documents should be produced at the time of admission at School of Pedagogical Sciences. The selection procedure will be strictly in compliance with the Prospectus and Kannur University Policy.

Hall ticket will be issued after the announcement of Entrance Exam date. Candidate can download it from University website. Candidate should go through the University website and University press release for latest information. Based on the entrance marks rank list will be published on the website. After that call letter will be issued to the candidates for admission. It can be downloaded from candidate's profile.

10. VERIFICATION OF DOCUMENTS:

The Head of the Department, School of Pedagogical Sciences shall be personally responsible for the verification of original documents and satisfaction of the correctness of the documents/records produced by the candidate, at the time of seeking admission. The candidates should fulfill the eligibility criteria prescribed at the time of admission in all respects, and all relevant documents shall be submitted at the Department during the time of admission. Candidates who report after the prescribed time and date of interview will forfeit all claims for admission. The Head of the Department, School of Pedagogical Sciences, reserves all the rights to reject any application or deny admission to any selected candidate if he/she is found to be unsuitable for the programme.

The Head of the Department should ensure identification of candidates during admission and verify their photographs uploaded at the time of registration.

- 3. B.Ed./Other Qualifying Examination Mark list and Certificate to prove Educational Qualifications
- 4. Service Certificate in Form IV (duly signed by competent authority) to prove service weightage (if any)
- 5. EWS certificate for eligible candidates (issued by Revenue Authorities.)
- 6. Caste certificate for SC/ST candidates
- 7. Non-Creamy Layer Certificate / Community Certificate for eligible candidates
- 8. Disability Certificate for Physically / Visually Challenged Candidates
- 9. Income certificate (if applicable)
- 10. Transfer Certificate of last studied institution

11. Call letter issued by university.

11. Special Instructions

- a) The University authorities shall be free to-make or amend any or total of the rules of procedure of admission at any time.
- b) Candidates who do not take admission on the prescribed date will forfeit all claims for admission.
- c) Fee once remitted will not be refunded under any circumstances.
- d) Any kind of false information will lead to cancellation of admission.
- e) Do not send hardcopies of the printout of the online application to the university. The hardcopy of the online application with supporting documents should be submitted at the time of admission to the Department.

12. Preventive measure against Ragging

If an applicant for admission is found to have been indulged in ragging in the past or if it is noticed later that the candidate had indulged in ragging, admission shall be revoked, or he/she shall be expelled from the educational institution. Candidate & Parents should submit the undertaking (see ANNEXURE III) to the College/KUTECs, before getting admission to the college.

13. Declaration against Dowry

Each of the student of the institution and his/her parents, or guardian are required to submit a combined undertaking at the time of admission in prescribed format available in Annexure I which is mandatory for admission against dowry.

14. Any other items not specifically covered in this prospectus shall be decided by the University and the decision taken therein shall be final.

Any disputes pertaining to allotment/ admission, shall fall only, within the jurisdiction of the Hon'ble High Court of Kerala.
