ORDER

1. The Regulations of Grading System for Under Graduate Courses under School of Distance Education with effect from 2008 admission was implemented and modified vide paper read (1) above, later certain modification were again effected to the regulations the w.e.f 2009 admission vide paper read (2) above .
- 2.The Regulations of Under Graduate and Post Graduate Programmes implemented under School of Distance Education w.e.f. 2011 admission were modified by fixing maximum duration for the completion of the programmes, at par with Regular UG/PG programmes vide paper read (3) above.
3. The Regulations of Afzal-UI-Ulama preliminary programme implemented under School of Distance Education w.e.f 2011 admission was modified by fixing maximum duration for the completion of the programme as four year vide paper read (4) above.
4. Examination Branch as per paper read (5) above requested to take necessary steps to conduct mercy chance examinations for eligible candidates who enrolled for UG courses (2009 Syllabus), Under Graduate, Post Graduate and Afzal UI Ulama Preliminary programmes (2011 syllabus), under School of Distance Education.
5. Subsequently, the matter was placed before the Standing Committee of Academic Council held on 05.12.2025, and the Vice Chancellor, considering the recommendation of the Standing Committee of Academic Council, ordered to place the matter before the Syndicate .
6. Further, the meeting of the Syndicate held on 18.02.2026 vide paper read (7), considered the matter and resolved to conduct Mercy Chance Examinations by levying a re-registration fee of ₹ 5000/- (Rupees five thousand only) and Course wise fee of ₹ 2000/- (Rupees two thousand



only).

7. The Resolution of the Syndicate vide item No.2026.051 has been implemented.

8. In view of the Resolution of the Syndicate (as per paper read 7) implemented in the University, sanction has been accorded to conduct Mercy Chance Examinations for candidates of UG courses under Grading System (2009 and 2010 admissions), Under Graduate , Post Graduate and Afsal - Ul- Ulama preliminary programmes implemented under the regulations of 2011, under School of Distance Education, levying the fee, as mentioned in paragraph (6) above.

9.The Examination Branch shall take further action for the conduct of Mercy Chance Examinations for students under School of Distance Education as detailed above by levying the fee, as mentioned in para (6)above.
