
- 1.The Regulation, Scheme, Syllabus & Pattern of Question Papers of Post Graduate Diploma in Learning Disability (PGDLD) I Year Course were implemented w.e.f. 2014 admission vide paper read (1) above.
2. As per the attendance criteria of the regulation ' A student admitted in the P G Diploma shall be required to attend at least 80% percent of the total number of classes (Theory/Practical) held during each semester. The student having less than prescribed percentage of attendance shall not be allowed to appear for the University Examination.
3. Academic D Section vide the Paper read 2 above, inquired whether there is provision to condone shortage of attendance for PGDLD programme, as the regulation of the programme is silent about the condonation of shortage of attendance.
4. Subsequently, clarification was sought from the Former Board of Studies Chairman, Psychology(cd), in this matter vide paper read (3) above,
5. As per paper read (4) above Former Chairman, Board of Studies, Psychology(cd) has informed that the condonation of shortage of attendance of 10 days(in one or two spells) can apply to the PGDLD programme of Kannur University.
6. The Vice Chancellor, after considering the above matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) Chapter III of Kannur University Act 1996 and all other enabling provisions read together with, **approved the recommendations of** Former Chairman, Board of Studies, Psychology(cd) and **accorded sanction to incorporate the provision of condonation of shortage of attendance under the criteria of attendance in the regulation of PGDLD programme of Kannur University as "The Vice- chancellor will grant condonation of attendance for a maximum of 10 days in one or two spells during the whole period of the programme (two consecutive semesters-one year).Benefit of condonation of attendance shortage will be granted to the students on health grounds, for participating in University Union activities, meeting of the University bodies and participating in extracurricular activities on production of genuine supporting documents with the recommendation of the Principal/ Head of the Institution . A student who is not eligible for condonation of shortage of attendance shall repeat the semester along with the subsequent batch in the same institution by availing readmission".**
- 7.The U O read as paper(1) above stands modified to this extent.
