1) PG Regulation Section-13, Evaluation and Grading Section 19 Grading System, Section 24-

Seven Point Indirect Relative Grading System is changed into Seven Point Indirect Grading

Both Internal & External evaluation shall be carried out using marks with corresponding grades and grade points in 7 point indirect grading system.
