Introduction of single valuation with revaluation, recounting and scrutiny for the Post Graduate examinations in the university Schools/Departments/Affiliated colleges/ School of Distance Education- with effect from valuations of all PG Programmes commencing after the issuance of this order - Clause 7.5 of the regulations of Post Graduate Programmes under Credit & Semester /Choice Based Credit Semester System in the University Schools/Departments , Clause 8.1 of the regulations of Post Graduate Programmes in semester pattern in Affiliated colleges w.e.f 2001 admission ,Clause 5 of Regulations of M.Sc Computer Science w.e.f 2004 admission , Clause 6 of Regulations of MCA w.e.f 2004 admission and clause 15.1 of revised regulations for Post Graduate Programmes in Affiliated colleges w.e.f 2014 admission -ammended - orders issued.

**ORDER**

1. Double valuation system of evaluation of the answer scripts is followed in the University for all the Post Graduate Programmes implemented vide reference 1, 2 ,3, 4 & 5 above in the schools/ Departments/ Affiliated colleges /School of Distance Education under the university .
2. Complaints have been raised by a section of students with respect to existing double valuation system. The syndicate meeting held on 17.01.2017, based on detailed discussion on the matter recommend to introduce single valuation with revaluation, recounting and scrutiny for the post graduate examinations in the university.
3. The Examination branch vide U.O note under reference (7) above, forwarded the syndicate resolution and requested the Academic Branch to take necessary action in implementing Single valuation for the post graduate examinations in the University.
4. As there was ambiguity with respect to the introduction of single valuation for which all PG Programmes , and the admission/exams to which the implementation of single valuation will be applicable, the Vice-chancellor under reference (8) above, ordered to introduce single valuation with revaluation, recounting and scrutiny for all the post graduate programmes in University Schools/Departments/Affiliated Colleges and under School of Distance Education and the same to be effective for the valuation of all PG courses commencing after the issuance of this University order,making ammendments in the relevant clause of the regulations for PG Programmes.
5. As per paper read (9) above, a committee was constituted to study the modalities in implementing single valuation for PG Programmes in the university, and vide reference (10) above, the committee recommend to

implement single valuation for PG Programmes after amending the respective clauses (Clause 8.1 of U.O read 1 above, clause 5 of U.O read 2, clause 6 of U.O read 3, clause 7.5 of U.O read 4 & clause 15.1 of U.O read 5 above) and also constituted a subcommittee for framing regulation for revaluation for post graduate programmes.

6. The Vice-chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) of KU Act 1996, and all other enabling provisions read together with, has accorded sanction to implement the recommendations of the committee to introduce single valuation with revaluation, recounting and scrutiny for the post graduate examinations in University Schools/Departments/Affiliated Colleges and under School of Distance Education coming under the purview of the above university orders and the same to be effective for the valuation of all PG courses (Home Valuation/CV Camp) commencing after the issuance of this University order and to amend Clause 7.5 of the regulations of Post Graduate Programmes under Credit & Semester /Choice Based Credit Semester System in the University Schools/ Departments , Clause 8.1 of the regulations of Post Graduate Programmes in semester pattern in Affiliated colleges w.e.f 2001 admission , Clause 5 of Regulations of M.Sc Computer Science w.e.f 2004 admission , Clause 6 of Regulations of MCA w.e.f 2004 admission and clause 15.1 of revised regulations for Post Graduate Programmes in Affiliated colleges w.e.f 2014 admission , with respect to double valuation is substituted as **single valuation with revaluation, recounting and scrutiny** to the above clauses of the PG Regulations. The sanction accorded is subject to ratification by the Academic Council.

7. This amendment will be applicable to all the Regulations of the PG Programmes implemented in the university since 2001 admission onwards.

8. Orders are issued accordingly.
