ORDER

1. The Revised Regulations for Ph.D Programme named as 'Regulations for Ph.D Registration and Award of Degree of Doctor of Philosophy 2011' was implemented in the University w.e.f 1.1.2011 vide paper read 1st above.

2. The letter, vide paper 2nd, states "Universities shall allocate the supervision from amongst the Regular faculty members in a Department or its affiliated PG Colleges/Institutes depending on the number of students per faculty member, the available specialization among the faculty supervisors and the research interest of the student. It is further clarified that any Ph.D/M.Phil degree awarded by a University under the supervision of a supervisor who is not a faculty member of the University or its affiliated PG colleges/Institutes would be in violation of UGC(Minimum standards and procedure for award of M.Phil/Ph.D) Regulations, 2009. Moreover, as per the clause 6.2 of the UGC Regulations read as 3rd above "only a full time regular teacher of the concerned University/Institution Deemed to be a University/College can act as a Supervisor.The external supervisors are not allowed."
3. The Syndicate Standing Committee on CRLP, vide paper read 4th above, recommended not to grant permission for doing Ph.D in Research Centres outside the jurisdiction of Kannur University and to exempt the Research Guides outside the jurisdiction of Kannur University from the notification 2017 onwards.Further resolved to permit the exempted Research Guides to guide the already registered students.
4. The Syndicate, vide paper read 5th above, resolved to approve the recommendations of the CRLP.
5. The following orders are, therefore, issued as approved by the Vice Chancellor:
 - i. The Research Guides working outside the jurisdiction of Kannur University are not permitted to guide Research Scholars from Kannur University. The Research Guides who are retired also are not permitted to guide Research Scholars from Kannur University.
 - ii. The Research Guides outside the jurisdiction of Kannur University and are retired are permitted to guide the already registered scholars.

- iii. The Research Scholars are not allowed to do Ph.D in Research Centres outside the jurisdiction of Kannur University.

Orders are issued accordingly.
