ORDER

1.As per Clause 4.1 of the Regulations for Under Graduate Programmes (Choice Based Credit Semester System) in Affiliated Colleges implemented w. e. f 2009 admissions vide paper read 1 above, " The Under Graduate Programme shall be completed within a minimum of six and maximum of twelve continuous Semesters, with provision for zero Semesters".

- 2. The Examination Branch as per paper read 2^{nd} above, placed the matter of granting One Time Mercy Chance Examination to the UG candidates of 2009-13 admissions, before the Academic Council for consideration.
- 3. The XXVIIIth meeting of the Academic Council,held on 25/6/2024 vide item No. II(8) (paper read 3) considered the Recommendation of the Examination Branch in this matter and resolved to conduct Mercy chance examination to the 2009-'13 admissions UG candidates, including the Students under School of Distance Education, by levying sufficient fee. It also resolved to refer the matter of fixing the fee to the Syndicate.
- 4. The meeting of the Syndicate held on 30/09/2024 vide paper read 4, considered the matter of fixing Re- registration fees as well as Course wise Examination fees, to be levied from the 2009 admission to 2013 admission UG Candidates, including the students under School of Distance Education, for the conduct of One Time Mercy Chance Examination and resolved to fix the Reregistration fee as ₹5000/- (Rupees five thousand only) and Course fee as ₹2000/- (Rupees two thousand only).
- 5. The Resolution concerned of the Syndicate has been implemented.
- 6. In view of the Resolution of the Academic Council (read vide paper read 3) and Resolution of the

Syndicate (as per paper read 4), which are implemented in the University, Sanction has been accorded to relax the Clause 4.1 of the Regulations for Under Graduate Programmes (Choice Based Credit Semester System) in Affiliated Colleges implemented w. e. f 2009 admission, and to conduct One Time Mercy Chance Examinations to 2009 admission to 2013 admission Under Graduate candidates in affiliated colleges, who have already crossed the maximum period for the completion of the programme, levying the Fee, as mentioned in Paragraph 4 above.

7. The Examination Branch shall take further action for the conduct of One Time Mercy Chance Examinations for 2009 -13 admissions UG (Regular) candidates by levying the Fee rate as fixed.
