ORDER

1.The Regulations, Scheme, Syllabus & Model Question papers of the Two Year Bachelor of Education (B.Ed.) Degree programme, in tune with NCTE Regulations 2014 were implemented in Kannur University w. e. f 2015 admission vide the paper read (1)above

2. As per the regulation of NCTE w. e. f 2014 admission, the eligibility criteria for B.Ed. programme is "Candidates with at least fifty percent marks either in the Bachelor's Degree and or in the Master's Degree in Science/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme".

3.. As per the U.O. read 1 above, B.Tech / B.E Degree was not included as the eligibility for admission to B.Ed programme.

4. The XXVth Academic Council held on 14.12.2022 considered the matter of inclusion of B.Tech /B.E programme as the qualifying degree for the admission to B.Ed programmes on the basis of the NCTE regulation and resolved to approve the same vide paper read 3 above.

5. The Single window cell vide paper read 4 above, sought clarification on the specialisation of B.Ed programme for which B.Tech / B.E graduates can be considered eligible for admission.

6.Considering the matter, the Vice- chancellor has constituted a three member committee to study and submit a report on the specializations of B.Ed programmes for which B.Tech/B.E graduates can be considered eligible for admission vide the paper read (5) above.

7. The committee convened its meeting on 13.06.2023 and 'After having a discussion regarding the subjects of study in various branches of Engineering, the committee recommends to consider B. Tech. graduates for admission to B.Ed. Programme in the following optional subjects w. e. f. 2023 admission.

(i) B. Ed Mathematics

(ii) B. Ed Physical Science

8. The single window cell vide the paper read 7 above intimated that the the Vice Chancellor approved the recommendations of the committee and requested to take follow up actions in this regard.

9. Considering the matter in detail, the Vice chancellor in exercise of the powers of the Academic

Council conferred under section 11(1) Chapter III of Kannur University Act 1996 and all other enabling provisions read together with accorded sanction to include B.Tech/B.E degree holders with 55% marks or equivalent grade also eligible to apply for B.Ed optional subjects Mathematics and Physical Science w.e.f. 2023 admission.

10. The U O read vide paper (1) above stands modified to this extent.

11. Orders are issued accordingly.
