Regulation for UG programmes under CBCSS-OBE w.e.f 2019 in affiliated Colleges – Clause 3.13 modified - Readmission in 6th semester to Under Graduate regular candidates of 2016 to 2018 admission following 2014 syllabus - permitted- Orders issued.

ORDER

- 1. The Regulations for U.G programmes under Choice Based Credit & Semester System (CBCSS-OBE) in Affiliated College were implemented in the University w.e.f 2019 admission and certain modification were effected as per paper read(1) above.
- 2. The clause 3.13 states that "Those students who have registered for First Degree (Under Graduate) programme under the Regulations for CBCSS for under Graduate Curriculum 2014 (KUCBCSSUG2014) in force from 2014-2018 admission, but could not successfully complete the programme due to discontinuation after registration at First or Second or Third or Fourth or Fifth semester examination, may be granted readmission in the discontinued semester subject to availability of vacancy and the age limit prescribed under 3.8, on cancellation of their previous examination registration. The candidates so readmitted shall also take ESE of all previous semesters as per the scheme and syllabus in force at the time of readmission as and when ESE is offered, and they shall also re-do CE of all previous semesters fulfilling all requirements as provided in the regulation by receiving such additional instructions as may be prescribed by and to the satisfaction of the department" and college and is silent about the readmission of candidates in 6th semester.
- 3. Academic D Section, as per paper read(2) above, submitted Note to the Academic Council "to consider the matter of granting readmission in 6th semester along with 2019 syllabus students, to the under graduate students who have completed up to 5th semester as per 2014 Syllabus, with the retention of marks secured by them in previous semesters" and the meeting of Academic Council as per paper read (3) above resolved to approve the same.
- 4. Meanwhile, readmission was granted to candidates (following 2014 syllabus) in 6th semester as per paper read (4), directing such candidates to appear for 6th semester examinations as per the existing syllabus, which is in effect from 2019.
- 5. Based on the requests from readmitted candidate (paper read 5), Academic D section sought clarification on the syllabus to be followed by candidates (following 2014 syllabus) readmitted in 6th semester along with candidates following 2019 syllabus, and also about retaining of their marks obtained in 1st to 5th semesters, as per paper read (6) above.
- 6. The Vice-Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 and other enabling provisions read together with, has accorded sanction to modify Clause 3.13, and issued the following orders, subject to report to Academic Council.
 - (i) Under graduate regular candidates (2016 to 2018 admission) who have completed fifth semester in 2014 Syllabus and readmitted to 6th semester

along with candidates following 2019 Syllabus, are permitted to appear for their 6^{th} semester examinations in 2014 Syllabus.

- (ii) The marks obtained by such candidates from 1st to 5th semester shall be retained, and register number of previous semesters shall be retained in 6th semester, by re-registering.
- (iii) Academic D Section shall take necessary steps to obtain an assurance in writing regarding the submission of internal marks in 2014 Scheme & Syllabus, from the principal of the respective institution where the candidate is readmitted.
- 7. The U. O read (1) stands modified to this extent Orders are issued accordingly.
