ORDER

1.As per paper read (1), the Regulations for UG Programmes (CBCSS-OBE) under Private Registration 2020 admission were implemented and certain modifications were effected to the same vide paper read(2) above.

2. The Clause 3.1 of the Regulation for UG programme under Private Registration states that "Eligibility : Basic Qualification for under graduate programme is a pass in plus two or equivalent course recognised by respective boards of Govt. of Kerala or Universities.

3. Since Afsal Ul Ulama (preliminary) is not equated to plus two or equivalent course, the students completed this programme requested to include Afsal Ul Ulama (preliminary) programme also as the eligibility for Admission to B A Arabic & Islamic History Programme under Private Registration. Considering the request, the Vice Chancellor has ordered to seek remarks of the Convenor, Ad hoc Committee Arabic (PG) Syllabus revision in this matter.

4. Accordingly, vide paper read (4) above, the Convenor, Ad hoc Committee Arabic (PG) Syllabus revision was requested to offer remarks on the matter of including Afsal Ul Ulama (preliminary) programme as the eligibility of Admission to B A Arabic & Islamic History Programme under Private Registration.

5. The Convenor, Ad hoc Committee constituted for Arabic (PG) syllabus revision vide the paper read (5) above, recommended to include Afsal Ul Ulama (preliminary) programme also as the eligibility of Admission to B A Arabic & Islamic History Programme under Private Registration.

6. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 ***accorded sanction to include Afsal ul Ulama (Preliminary) programme also as the eligibility of Admission to B A Arabic & Islamic History Programme under Private Registration w.e.f 2023 admission and to add the same as Clause 3.1 (a) as detailed below, in the Private Registration Regulations for UG Programmes (CBCSS-OBE) and to report the same to the Academic Council.***

Clause 3.1(a) : Those who have Afsal ul Ulama (Preliminary) certificate are also eligible for admission to B A Arabic & Islamic History Programme under Private Registration w.e.f 2023 admissions.

7. Therefore, U. O. read as paper (1) & (2) above stand modified to this extent.

8. Orders are issued accordingly


