### ORDER

- 1. The meeting of the Convener of the FYUGP Curriculum Regulation Committee, the Chairperson of the Board of Studies in Computer Science (UG), and the Head of the Department of Information Technology held on 21.10.2024 considered matters related to the conduct of practical classes, including the components of Continuous Comprehensive Assessment (CCA) for the Practical Part of the Three Year B.C.A. (FYUGP Pattern) Private Registration Programme (2024 Admission) and guidelines for conducting End Semester Evaluation (ESE) and Continuous Comprehensive Evaluation (CCA) of courses offered as DSC in Computer Application (Major/Minor) with practical and made recommendations in this regard vide paper read as (4) above.
- 2. The Syndicate meeting held on 29.11.2024 vide item no 2024.1042 approved the recommendations of the above Committee vide the minutes read as 4 above.
- 3. The Syndicate resolution has been implemented by the Registrar, and the guidelines for conducting End Semester Evaluation (ESE) and Continuous Comprehensive Assessment (CCA) of courses (papers) offered as DSC in Computer Application (Major & Minor) for private registration candidates of Three Year UG (FYUGP pattern) Programmes of 2024 Admission, as approved by the Syndicate, are issued accordingly as given below, as directed by the Registrar.
- 4. Guidelines for Conducting End Semester Evaluation (ESE) and Continuous Comprehensive Assessment (CCA) for Papers Offered as DSC in Computer Application (Major & Minor) for Private Registration Candidates of Three-Year UG (FYUGP Pattern) Programmes of 2024 Admission.

#### **B. Courses Without Practical**

i. In the case of courses having 4 credits without practical, ESE of 2 hour duration for 70 marks shall be conducted by the Controller of Examinations. Continuous Comprehensive Assessment (CCA) for 30 marks shall be based on Assignment as provided in Clause 13.2 of the Regulations for Three Year Undergraduate Programmes as per the FYUGP Pattern under the Private Registration Scheme of the School of Lifelong Learning 2024 (KU-SLL-FYUGP-REGULATIONS 2024).

ii. In the case of courses having 3 credits without practical, ESE of 1.5 hour duration for 50 marks shall be conducted by the Controller of Examinations. Continuous Comprehensive Assessment (CCA) for 25 marks shall be based on Assignment as provided in Clause 13.2 of the Regulations for Three Year Undergraduate Programmes as per the FYUGP Pattern under the Private Registration Scheme of the School of Lifelong Learning 2024 (KU-SLL-FYUGP-REGULATIONS 2024).

## C. Courses Having 4 Credits with Practical

i. For courses having 4 credits with practical, ESE of 1.5 hours for 50 marks shall be conducted by the Controller of Examinations. ESE Practical examination for 15 marks shall also be conducted by the Controller of Examinations (Total = 65 marks (50 + 15)).

ii. Continuous Comprehensive Assessment (CCA) for 25 marks on the theory part shall be based on a Test Paper (15 marks) and Assignment/Viva/Seminar (10 marks)-(Total 25 marks). Continuous Comprehensive Assessment (CCA) for 10 marks on the practical part shall be based on the continuous evaluation of Lab activities.

Marks for the Continuous Comprehensive Assessment for 35 marks (25+10) shall be awarded by the faculty handling practical classes based on the above components.

**D.** Continuous Comprehensive Assessment marks awarded shall be communicated to the Controller of Examinations by the Centre Coordinator, along with the mark sheet, duly signed by the faculty concerned.

**E.** All documents related to the Continuous Comprehensive Assessment (CCA) shall be kept in the safe custody of the Centre Coordinator until the expiry of two months from the publication of the result of the ESE of the course concerned. The documents, as and when called for, shall be submitted to the University.

5.The Vice Chancellor has also ordered that a course in computer application involving practical classes be offered as Minor/MDC for candidates of other programme only if a minimum 10 candidates opt for such course as their Minor/MDC, and in case registration is less than 10, candidates be directed to opt for other eligible courses as their Minor/MDC from the list of courses approved for private registration three year Undergraduate FYUGP pattern programmes.
