As per paper (1) above, Scheme, Syllabus and Pattern of question papers of Core, Complementary Elective and Generic Elective Courses of B.A Sanskrit Programme under Choice Based Credit and Semester System (Outcome Based Education System-OBE) in Affiliated Colleges, were implemented with effect from 2019 Admission.

2. As per paper read (2) above, Examination Branch informed that the total marks, ESE and CE of 6th Semester Core Course XVI: Project (6B16SKT) are not clearly specified in the syllabus of B.A Sanskrit Programme under Choice Based Credit and Semester System (Outcome Based Education System-OBE) implemented with effect from 2019 Admission.

3. In the light of the Judgment as per paper read (3) above, all activities of reconstituted/constituted 72 Board of Studies (w.e.f 11/06/2021), are kept in abeyance until assent from the Hon'ble Chancellor is received.

4. Considering the exigency of the matter and as ordered by the Vice Chancellor, Dr. Anitha Kallyadan, Former Chairperson (2018-'20 Period), Board of Studies in Sanskrit (Cd) was requested to offer necessary clarification in the syllabus as per paper read (4).

5. As per paper read (5) above, Dr. Anitha Kallyadan, Former Chairperson, Board of Studies in Sanskrit (Cd) submitted the modified Syllabus part of the 6th Semester Core Course XVI: Project (6B16SKT) clearly specifying total marks, and marks for ESE and CE as follows.

#### Maximum Marks for the Course - 25

#### Internal - 5, External - 20 (Project Evaluation and Viva)

6. The Vice-Chancellor, after considering the matter in detail, and in exercise of the powers of the Academic Council, as per Section 11 (1), Chapter III of Kannur University Act, 1996 has accorded sanction to implement the modified Syllabus part of 6th Semester Core Course XVI: Project (6B16SKT) clearly specifying the total marks, ESE and CE, as detailed in para 5 above, for B.A. Sanskrit Programme CBCSS (OBE) in affiliated colleges w.e.f. 2019 admission, subject to report to Academic Council.

#### Guidelines for the Conduction and Evaluation of Project.

- 1. Each student should be assigned a supervising teacher to guide in the project work.
- 2. Project topics should be selected by the students after discussion with the supervising teachers.
- 3. Awareness of Research Methodology should be created among the students.
- 4. Synopsis of the Project should be submitted to the Department at the beginning of the V Semester.
- 5. Internal Assessment should be completed 2 weeks before the last working day of VI semester and the marks should be published in the Department.
- 6. One copy of the Dissertation (either in English or in Sanskrit) should be submitted at end of the VI Semester.
- 7. Evaluation of the Project Report shall be done under Mark System.
- 8. The evaluation of the project will be done at two stages:

a) Internal Assessment (Supervising teachers will assess the project and award internal marks)

b) External evaluation. (External Examiner)

c) Marks secured for the project will be awarded to candidates, combining the internal and external Mark.

- 9. External Examiner will be appointed by the University from the list of VI semester Board of examiners in consultation with the Chairman of the Board.
- 10. The chairman of the examination (VI semester) should form and coordinate the evaluation teams and their work.
- 11. Chairman, Board of Examination, may at his discretion, or urgent requirements, make certain exceptions in the guidelines for the smooth conduct of the evaluation of the project.
- 12. The internal to external components are to be taken in the ratio of 1:4, Assessment of different components may be taken as below.

# **Preparation and submission of Project Report**

- 1. The project must be typed in A4 size paper.
- 2. Project should be prepared either in Sanskrit or in English. If in Sanskrit, use Unicode font in 16 size and in 1.5 line space and If in English, use Times New Roman font in 14 size and in 1.5 line space.
- 3. Endnotes, Bibliography and References must be given in a standard reference format (APA/MLA).
- 4. The Project record must be either spiral/hard bounded and the minimum number of pages should be 25.
- 5. The Supervising Teacher should ensure the dissertation is free from plagiarism and a certificate to this effect is to be obtained from the student.
