Vice-Chancellor reported the appointment of Dr. Rajkumar K.K., Professor, Dept. of Information Technology as the Controller of Examination-in-charge. Also briefed the following matters at the meeting: • Academic infrastructure of the University departments, including 29 teaching departments, 3 Teacher Education Centres, 2 MBA Centres, 1 IT Education Centre, and 1 Law Centre, with a total student capacity of 3,150. • About the hostel capacity for around 690 the students across the nine campuses of the University. • Major projects and overall development of the University, including the implementation of PM-USHA (Pradhan Mantri Uchchatar Shiksha Abhiyan). • University's academic initiatives, particularly the introduction of FYIM programmes. • Regarding examination and governance reforms, reported on the implementation of a Centralised Question Bank System, Automated Question Paper Generation, and Online Question Paper Transmission, including On-Screen Marking and Digital Evaluation System aimed at improving efficiency, transparency, and security in the examination process. • Further briefed the members on the University's research and innovation initiatives, ongoing and proposed construction works, and the financial position of the University.
