- 1. As per paper read(1) above, Scheme and Syllabus and pattern of Question Papers of B A Bharathanatyam programme(CBCSS-OBE), was implemented in affiliated colleges w.e.f 2019 admission.

As per the Scheme of above mentioned programme, mark distribution for the course 6B15 BHA; Bharathanatyam Practical Stage Performance 7(P) is given as 40+10=50 where as in its detailed syllabus it is specified that "there will not be a Continuous Evaluation". Hence the examination branch, as per paper read (2), requested clarification on the same.
- 3. As all activities of the reconstituted Board of Studies are kept in abeyance in the light of the judgement in WA No. 1530/2021 dated 22.03.2022, the former chairperson, Board of Studies in Dance(Cd)(2018-20) was requested to offer clarification in this regard, as per paper read (3).
- 4. The former chairperson, Board of Studies in Dance(Cd) (2018-20) as per paper read (4) clarified that there is internal evaluation for the course 6B15 BHA; Bharathanatyam Practical Stage Performance 7(P) and mark distribution is 40 for External (ESE) and 10 for Internal (CE).

The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) chapter III of Kannur University Act 1996, accorded sanction to implement internal evaluation for the course 6B15 BHA; Bharathanatyam Practical Stage Performance 7(P) in the Syllabus of B A Bharathanatyam w.e.f 2019 admission, with mark distribution of 40 for External (ESE) and 10 for Internal (CE), subject to report to Academic Council.
