ORDER

1. The Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy 2011 was implemented in this University w e f 01-01-2011, in compliance with the UGC Regulations on minimum Standards and Procedure for the Award of Ph.D Degree Regulation 09.

2. As per regulations, coursework was made mandatory to all Ph.D Programmes. As per this regulation candidates registered for coursework shall undergo a coursework of six months/one semester duration and all shall appear for the Preliminary Qualifying Examination within one year of getting registration. The Preliminary Qualifying Examination Consists of two theory papers, Dissertation and Viva-voce.

3. The coursework for 2014-15 batch was started on 01-12-2014 at each coursework centres identified for the particular subject.

4. Vide the reference read (2) above, the scholars who have completed coursework were permitted to attend the concerned research centres from the very next day of completion of coursework.

5. The research scholars who have completed coursework during 2014-15 had to submit their Preliminary Dissertation by 30 November 2015, ie. within one year of registering to PhD programme(ie. Joining to coursework).

6. Vide the reference read (3) above, an extension of time upto 30-11-2016 was granted for the submission of the preliminary dissertation to the research scholars who have completed coursework during 2014-15, by remitting a fine of Rs. 5,000/- .

7. Some scholars have requested for further extension for the submission of the preliminary dissertation and the matter was placed before the Syndicate and the Syndicate resolved to extend the time upto 31-01-2017, by remitting a fine of Rs. 10,000/- and not to grant further extension under any circumstances.

8. The following order is therefore issued on the matter as approved by the Vice Chancellor by implementing the Syndicate resolution.

The time limit for the submission of Ph.D Preliminary Dissertation for those research scholars who have completed coursework during 2014-15 batch is extended upto 31-01-2017, by remitting a fine of Rs. 10,000/- and no further extension shall be granted, under any circumstances.
