ORDER

1. As per the paper read as (i) above, the recommendations of the Board of Studies in Management Studies (PG) regarding the Recognition/Equivalence of Degrees of other Universities were placed before the meeting of the Standing Committee of the Academic Council, for consideration. Subsequently, the meeting of the Standing Committee of the Academic Council, held on 12.03.2026, vide the paper read as (ii) above, considered the recommendations and recommended to approve the following recommendations of the Boards of Studies in Management Studies (PG).

i) Not to recognize the MBA in Tourism Administration (Regular) degree of Mangalore University, Karnataka as equivalent to the MBA degree of Kannur University for any purpose.

ii) Not to recognize the M.Tech in Human Resource Development (Regular) degree of University of Madras, Tamil Nadu as equivalent to the MBA Degree of Kannur University for any purpose.

After considering the matter in detail, the Vice Chancellor, exercising the powers of the Academic Council conferred as per the Section 11(1), Chapter III of Kannur University Act, 1996, approved the aforesaid recommendation of the Meeting of the Standing Committee of the Academic Council held on, 12.03.2026 (item No. 9) and issued orders regarding the recognition of the aforesaid Degrees awarded by various universities, as detailed in Para 1 above, and to report the matter to the Academic Council.
