ORDER

- As per paper read (1) above, the Regulations for UG Programmes under Choice Based Credit & Semester System (CBCSS) in Affiliated Colleges were implemented in the University w.e.f. 2014 admission and certain modifications were effected to the same as per paper read (2).
- 2. As per paper read (3) above, the Syndicate resolved to issue Rank certificate instead of Position Certificate to UG candidates, with effect from 2018 admission on wards and also to amend the Regulations accordingly, so as to enable eligible candidates to avail UGC Scholarships which mandates Rank Certificate for considering the application.
- 3. Accordingly, the second para of the Clause 12 in the Regulations for UG Programmes (CBCSS) in Affiliated Colleges w.e.f 2014 admission has been modified, to issue Rank Certificate instead of Position certificate to U.G Candidate with effect from 2018 admission on wards, as per paper read (4) above. Subsequently, the meeting of the Syndicate, held on 19.01.2021, resolved vide item No. 2021.080 to modify the Syndicate resolution item No.2020.564 dated 21.12.2020, regarding issuing of Rank certificate instead of Position Certificate, by replacing the date of effect as 2017 admission on wards, instead of 2018 admission on wards.
- 4. The Vice Chancellor, after having considered the matter in detail and in exercise of the powers of the Academic Council as per section 11(1) Chapter III of Kannur University Act 1996, accorded sanction to modify date of effect of issuing Rank Certificate as 2017 admission on wards and to modify the Regulations accordingly.
- 5. The following modification is therefore made in the second para of the Clause 12 of the Regulations of UG Programmes (CBCSS) 2014.
- Instead of Position Certificate, 'Rank Certificate' (up to the 3rd rank) shall be issued to the U.G.(Under Graduate) candidates with effect from 2017 admission on wards, on the basis of highest marks secured for the programme. In the case of a tie, highest of OGPA shall be considered.
- 6. The U.Os read (1),(2) & (4) above stand modified to this extent.

Orders are therefore issued accordingly.
