ORDER

1. As per the Guidelines for University Junior Research Fellowship, "The candidates who have already registered for Ph.D programme in any of the university Departments or University recognized research Centers under Kannur University and who are qualified in the test conducted by the university for the purpose shall be eligible for the award of Junior Research Fellowship, subject to the conditions as may be determined by the Syndicate"
2. Vide the reference read (2) above, 103 full time research scholars had been awarded the University Junior Research Fellowship @ Rs.5000/-(Rupees Five thousand only)per month upto 31-03-2017 and Rs.10,000/- per month w.e.f 01.04.2017 for a period of 3 years .The 1<sup>st</sup> tenure of the Fellowship will be for the coursework period of six months and the remaining tenure of the Fellowship may be reckoned from the date of joining at the research centre based on the formal registration order from the University.
3. Vide the reference read (3) above , University Junior Research Fellowship scholars who have completed coursework were permitted to attend the concerned research centers from the very next day of completion of coursework and from 2014-15 coursework batch onwards, there is no gap of time period for the scholars between the completion of coursework and the date of joining at the research centre.
4. Out of the above 103 research Scholars availing Junior Research Fellowship ,the following 40(Forty) research Scholars have now become ineligible for the award of Junior Research Fellowship (as the tenure expired/converted to part time/selected by other funding agencies/discontinued/submitted the final thesis/Bill and progress report has not been submitted within the prescribed time) and they are excluded from the list of awardees as per the orders of the vice-chancellor

6. The Finance branch vide Endt.No:Fin.B/Endt/2018.19 dated 07-07-2018 has allotted Rs. 1,00,00,000/- (Rupees One Crore only ) to the Head of Account MH-28-428-276 research Fellowship(plan Head of Account) during the financial year 2018-19.

7. Meanwhile, the Vice- Chancellor has ordered to award university JRF to 37 number of newly registered full time Research Scholars, in addition to 63 number of full time research scholars who were awarded University JRF, vide U.O No.Acad E3/University JRF/2017 dated 24-06-2017.

8. The Vice Chancellor, after considering the matter in detail, has accorded sanction to award the University Junior Research Fellowship @ Rs-5000/- per month upto 31-03-2017 and @ Rs-10,000/-per month with effect from 01-04- 2017 to the research scholars mentioned on para no.5 above.

9. The following orders are therefore issued on this matter:

- i. The University Junior Research Fellowship in respect of 40 research scholars who are ineligible due to various reasons as mentioned on para no.4 is cancelled.
- ii. The tenure of University Junior Research Fellowship is three years and the amount per month is Rs-5000/- (Rupees Five thousand only) upto 31.03.2017 and 10,000/-(Rupees Ten Thousand only) w.e.f 01.04.2017. For those scholars who have done the coursework and a break occurred before joining the research centre, the first tenure of the fellowship may be released from the date of joining to coursework based on the certificate issued by the coursework co-ordinator .The remaining tenure of the fellowship will be reckoned from the date of joining at the research centre after the completion of coursework.
- iii. The fellowship will be awarded subject to the availability of funds in the University.
- iv. The scholar should furnish their employment status once in six months.
- v. The Research fellows are not permitted to accept any assignment ,paid or unpaid during the tenure of award of University Junior Research fellowship .A certificate from the Research Guide ,countersigned by the Head of the Research Centre ,to the effect that the research scholar is not availing any other financial assistance ,shall be submitted each time when the candidate applies for University Fellowship.
- vi. Only Full -Time Research Scholars and whose research works are regularly monitored by the concerned Research Guide are eligible for University JRF. In case the Research Guides who are not available for regular monitoring of research work of a Research Fellow, the Head of the Research Centre will intimate the status for taking a decision in the award of JRF further. The decision of the University in this regard will be final.
- vii. The progress Report of Research work, Attendance certificate, stamped receipt, prior permission letter from the Guide and Head of the research centre for duty leave and a copy of the U O sanctioning the fellowship shall be enclosed each time with the bill claiming the University JRF.

- viii. The Research Fellows are entitled for a maximum period of 15 (fifteen) days leave in a calendar year, in addition to Public Holidays, 30 days of duty leave per year and 6 months of special duty leave for the completion of field work/field reference/lab work during the entire research period, with fellowship. Women candidates are eligible for maternity leave as per rules once during the tenure of the award.
- ix. The Research Fellows who are availing leave for data collection and other outstation research activities shall obtain prior permission from the Head of Research centre through the Research Guide. An attested copy of the request approved by the Research Guide, shall be forwarded to the University by the Head of the Research Centre, along with the application for Junior Research Fellowship.
- x. The fellowship now ordered shall be terminated at any time during the tenure and the decision of the University will be final in this regard.
- xi. The Fellowship granted shall be cancelled, on misconduct of the Research fellow, unsatisfactory progress report of Research, lack of regular supervision of research work by the Research Guide concerned and ineligibility of the Research Fellow for the award of JRF, if found later.
- xii. Full time scholars who availed University Fellowship and failed to submit the final thesis before the due date as per registration, will have to refund the entire fellowship amount. Any lapse in this regard will be treated as the liability of the Research Guide too. An affidavit in stamp paper worth Rs.100/- should be submitted along with the bill to this effect.
- xiii. Full time scholars who are eligible to avail the fellowship have to submit the bill and other documents claiming the Fellowship for every completed six months, failing which the fellowship granted is liable to be cancelled.
- xiv. The expenditure towards the award of Fellowship will be met from the Head of Account 'MH-28-428-276 Research Fellowship(plan-Head of Account)of the current year's budget estimates.
- xv. The University Order read (2) above stands modified to this extent.


